COVID-19 - CECA SCOTLAND UPDATE

Introduction

CECA Scotland will be producing regular updates to keep member companies updated on new developments relating to the Covid-19 coronavirus and its impact on the Scottish civils sector. COVID-19: Physical Distancing Update

The Scottish Government has today (2 July) announced an update on the approach to physical distancing in light of advice from the Scottish Government COVID-19 Advisory Group (which you can read here). You can also read guidance received from the Advisory Group on "Superspreader" events here, which highlights the risk of large numbers of people gathering indoors at close proximity, such as in large factories, in care homes or at conferences.

The 2-metre rule will remain the default physical distancing requirement for Phase 3, however there will now be some exceptions for a limited number of sectors and settings, following agreement of appropriate and necessary mitigating measures. The sectors which qualify for exemption are public transport, outdoor hospitality, indoor hospitality and retail. Other settings will be reviewed for potential exceptions, but 2 metres will remain the default (including in construction).

Other announcements in the First Ministers Daily Update (2nd July)

The First Minister also outlined changes which will come into force over this weekend.

- Travel distance limit relaxed 3 July (except for people living in Gretna, Dumfries, Lockerbie, Langham, Cannonbie and Annan where the 5-mile limit will stay for now)
- Self-catering accommodation and second homes (without shared facilities) permitted 3 July
- Outdoor hospitality (subject to physical distancing rules and public health advice) 6 July
- Children under 12 will no longer need to maintain physical distancing with other children or adults outdoors.

• Older children and young people aged 12-17 can continue to meet in groups outdoors as in existing rules (maximum of 3 households in the group, no more than 8 people in total). However, there will now be no limit to the number of these groups that the young person can meet in a day. 12-17 year olds should continue to physically distance.

Face Coverings in Shops

From the expected start of phase 3 (10 July), wearing face coverings will also be mandatory in shops, with some exceptions.
