Quality of Work Employer Survey

IES is conducting a survey as part of a policy research project on behalf of the Health Foundation, focused on understanding how young people (aged 16-25) can be supported into good quality work through better policy and practice. The survey looks to explore employers' views, experiences and challenges when it comes to young people and good quality work, as well as looking at practices around engagement with education, and challenges in recruitment. The multiple choice survey will take 5-10 minutes to complete and is aimed at businesses/employers. It asks about your views and experiences around youth employment, including your views on good quality work, recruitment and workplace practices, challenges, and support needs. This research will allow IES to develop findings to share with policymakers and with employers across the country – creating an opportunity to gain valuable insight into the experiences of employers, develop recommendations and build a case for action. IfATE Route Panels - Applications Open

The Institute for Apprenticeships and Technical Education (IfATE) has just launched its annual recruitment for membership of its route panels. If ATE is looking for employers with expert knowledge and experience to offer an authoritative view on the skills requirements in their sector. If ATE's aim is to ensure that apprenticeships and technical qualifications provide opportunities for the broadest range of individuals and employers and are viewed and respected as highly as other education routes. To help drive this work, IfATE have appointed 15 sector-based route panels, made up of individual employers chosen for their outstanding sector knowledge, experience and expertise. Route panel members provide strategic oversight for the sectors in which they operate, drawing on their knowledge and experience of the day-to-day realities of different occupations in those sectors to help shape skills development. They understand existing and future skills needs, enabling them to advise, challenge and make recommendations on the relevance, quality and credibility of apprenticeships, technical qualifications and other technical education products. Route panels currently meet once every eight weeks. Most meetings are held remotely, enabling members to dial in. From time to time, IfATE invite members to attend meetings or other events in person, including bi-annual membership summits. These are usually held in London but may occasionally be hosted in other parts of the country by panel members themselves. This is a three-year appointment, subject to successful completion of the first year. Appointments may be extended by mutual agreement. Route panel members (other than chairs, who receive a nominal payment to cover the additional elements of their role) are not paid a fee. They may though claim expenses incurred as a result of attending panel meetings and other Institute activities, in accordance with IfATE's expenses policy.
