#### **Construction Leadership Council - Net Zero Sites Consultation**

Businesses from across the sector are being asked to give their views on the first ever unified plan to slash the amount of diesel used on sites. Last year the Construction Leadership Council's CO<sub>2</sub>nstructZero campaign set a target to cut the amount of diesel used by construction by 78% by 2035. Since this announcement, a group of organisations including contractors, plant firms, clients and trade bodies have been working together to set out a plan for how this target can be achieved. The outcome of this work – Consultation Draft: Zero diesel sites route map – has been published to provide firms across the industry with an opportunity to give their feedback on the proposals. #### **Government Grants To Install Electric Vehicle Chargepoints**

The Office for Zero Emission Vehicles champions the take-up of electric vehicles across the UK. Installing chargepoints can be hugely beneficial for your business. You can potentially claim 100% of the costs of installing an electric vehicle charging point as a capital allowance. Some of the expenditure may also qualify for the new super deduction, equating to a 130% enhanced deduction of the total cost. There are grants of up to £350 to cover the cost of buying and installing a chargepoint. Further grants, of up to £15,000, are available to small and medium sized businesses to help cover the cost of installing chargepoint infrastructure. Find out more here. Grants are also available to companies renting out commercial units (see here). To apply, businesses will need to have a Companies House or VAT number.

#### **Businesses To Be Give UK Product Marking Flexibility**

Businesses are to be given an additional 2 years to apply new product safety marking. The UK Conformity Assessed (UKCA) marking has been introduced as part of the UK's own robust regulatory framework. It shows that products comply with our product safety regulations which are designed to protect consumers. However, given the current economic climate, the UK Government has announced that the original deadline for changing to UKCA marking, which was to be the end of this calendar year, has now been extended to 31 December 2024. #### Autonomous Plant in the Industry

CECA has been approached by the HSE to help determine the extent of autonomous plant being used across infrastructure projects. Whilst this machinery can be invaluable in certain situations, the research is looking at whether this machinery is adequately covered through existing safe working practices guidelines and for that matter, training provision. ## **CECA Working with Cabinet Office**

CECA has also been approached by the Geospatial Commission within the Cabinet Office to carry out a review of the current stage of the NUAR (National Underground Asset Register) programme. They are looking for a small working group comprising a range of Tier 1, Tier 2 and SME organisations who work directly within the utility sector and who are keen to be involved in assessing the proposed platform which is currently classed as 'private beta' – this means the system can be assessed by actual practitioners who can also provide feedback to the geospatial team.
