RAPID Ofwat Supply Chain Questionnaire

The Ofwat RAPID (Regulators' Alliance for Progressing Infrastructure Development) team would like to gain an understanding of the supply chain's views/opinions/knowledge on the upcoming RAPID pipeline. Please find the link to the survey here. All responses will be automatically recorded on the MS Forms system. Deadline for responses is **15 May 2023**. (Note: RAPID has been set up to identify and address issues relevant to the development of joint infrastructure projects and to analyse the feasibility of nationally strategic supply schemes. 18 schemes have been proposed so far and we are encouraging more schemes to be planned. These schemes have the potential to help meet the water needs set out in the National Framework for England).

CITB HS&E Test for Managers & Professionals

The CITB HS&E test for Managers and Professionals will be changing on Tuesday 27 June 2023. To pass the new test CITB are strongly recommending that candidates revise using the new revision materials. The new test will cover six additional subjects of relevance to today's managers: mental health; leadership; occupational health governance; behavioural safety; new technologies; and improving legislative compliance. The updated revision book (GT200-V9) is available to purchase from the CITB shop, and the



official CITB HS&E test app for managers and professionals revision app is available to download from the Apple App Store and the Google Play Store. CECA Meeting with Ofwat Chairman

CECA recently met with the Chairman of Ofwat, Iain Coucher, to better understand the challenges of completing AMP7 and how the industry is preparing for AMP8. It was confirmed that there will be a significant increase in spend in AMP8 compared to AMP7 but the split between TOTEX and OPEX will need clarifying in most cases. Once determined, the level of spend on Capital projects should be a little clearer. Spend in AMP8 is likely to focus on the removal of Nitrogen from receiving watercourses, stormwater overflows, water resilience, and leakage – although it was noted that not all water companies would have the same level of spend in each area.
